## Why Give?

## Bequest Types

- Allocation to Fair Haven of a specific dollar amount from your estate.
- Allocation to Fair Haven of the residual amount or a percentage of your estate.
- Allocation to Fair Haven of a specific asset or items from your estate, such as a piece of property or a vehicle.

## Advantages of Bequests

- Reduced taxes - your estate will receive a valuable tax credit.
- It's flexible - bequests can be for a specific amount, a percentage of the estate or residual of the estate and you may designate your charitable gift to a specific fund or project at Fair Haven that interests you most.
- Your will can be amended or revoked by you at any time.
- It's easy to do by contacting your lawyer! All it takes is a simple clause in your Will to leave a gift of hope to Fair Haven.

## How to Get Started

First, decide how much you would like to give. Remember, even a gift of 1%-5% of your estate can make an impact, helping us to provide the best care to residents well into the future.
